Upon the completion of your EV Form(s) you (the student) will receive an email from AdobeSign requesting your electronic signature. Once your signature is received, your parent/guardian will receive an AdobeSign email requesting their electronic signature, followed by your high school Principal/Designee's request for an electronic signature.

Please allow our office up to 3-4 weeks for review and processing of your Application and EV Form(s). We ask that you consistently check your email for updates and communication from our office.

Once all documents are reviewed, an admissions decision will be made or communication will be sent to you (the student) requesting additional documentation if needed for further evaluation. Once your EV Form has been approved and processed, you will receive an Acceptance Letter for the term(s) you are entering.
